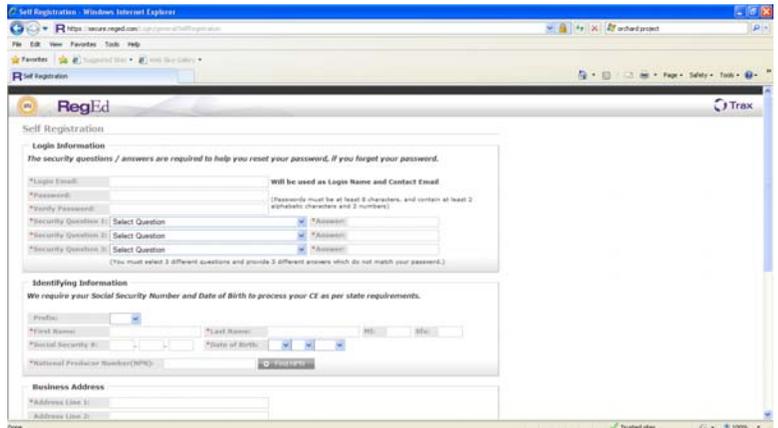

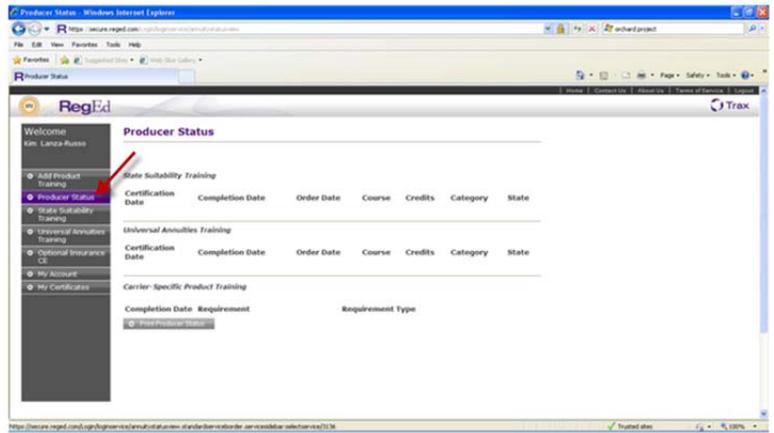
- Access the RegEd Annuity Training Platform.

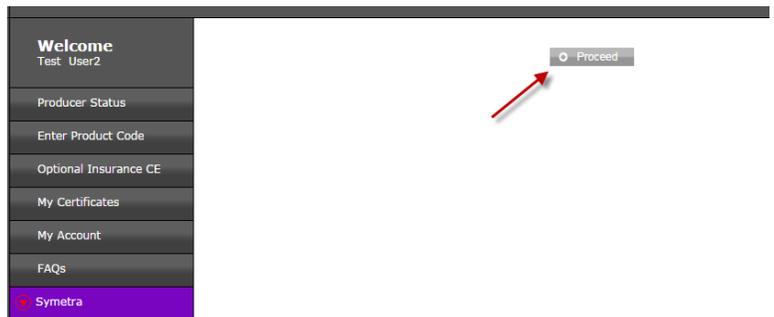


- Locate Symetra from the list of Carrier-Specific Product Training and click 'Go To Requirement' to begin the presentation.

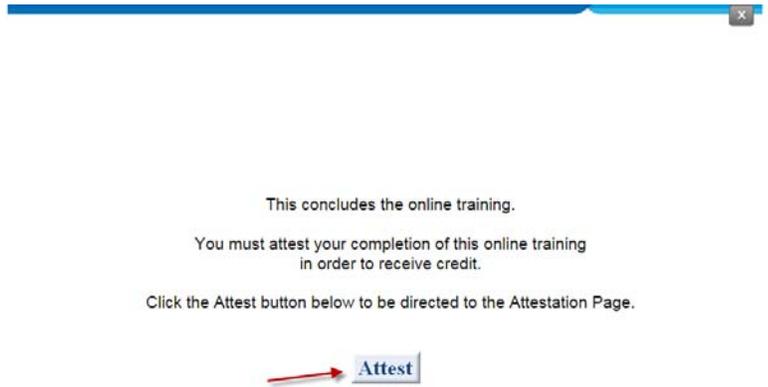

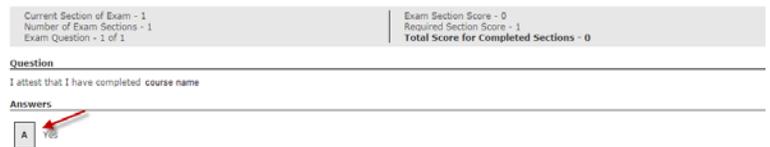
